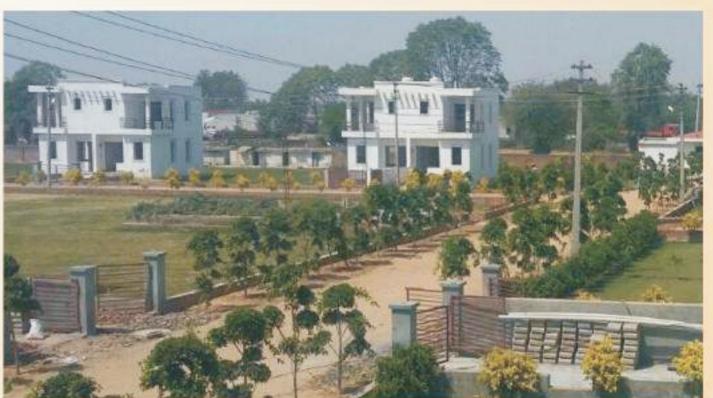

# INDICATIVE TERMS & CONDITIONS FORMING PART OF THIS APPLICATION FOR ALLOTMENT OF RESIDENTIAL PLOT/VILLA/SHOP IN 'MANSHA ROYAL CITY' AT VILLAGE-CHANDHUT, SH-22 A, ALIGARH ROAD, PALWAL

The terms & conditions given below are of indicative nature with a view to acquaint the applicant with the terms & conditions as comprehensively set out in the builder-buyers agreement which would be executed between the applicant(s) and the company.

- The intending allottee(s) has applied for allotment of a Plot/Villa/shop with full knowledge and subject to all the laws/notifications and rules applicable to this
  general, which have been explained by the company and understood by him/her
- 2. The allotment of the plot/villa/shop is entirely at the discretion of the company the allotment of the said residential plot/villa/shop shall be provisional.
- That the provisional allotment made at the time of singing of allotment Letter/builder-buyer's agreement shall be deemed final allotment for all the legal purposes.
- 4. The intending allottee(s) has fully satisfied himself/herself about the present title/decontrolled status of the land which is freehold and the interest & arrangement of the company in the land on which the project is being developed and constructed and has understood all limitations and obligations in respect thereof.
- The intending allottee(s) has examined the plans, designs, specification of the plot/villa which are tentative and agree that the company may effect such variations, alterations, deletions & modifications therein resulting in change in the position of the Plot/Villa/shop, changes in its number, area, dimensions, layout etc. as may in its sole discretion deem appropriate or may be done by any competent Authority. The intending allottee(s) hereby agrees that no claim, monetary or otherwise will be raised in case of any such change. - 7. That timely payment of installments and all other charges pertaining to the residential plot/villa/shop is the essence of the terms & conditions. However in the event of breach of any of the terms & conditions by the intending allottee, the allotment shall be cancelled at the discretion of the company and the earnest money together with any interest on installments due but unpaid and interest on delayed payment and other administrative charges shall be forfeited. The balance amount if any shall be refunded to the applicant without any interest.
- 8. It shall be incumbent upon the applicant to comply with the terms of payment as per payment plan and applicant has agreed that company is under no obligation to send reminder for payments. The applicant agrees to pay the interest on delayed payment @ 18% p.a. on the amount outstanding up to 2 months delay from the due date of payment and @ 24% p.a. thereafter for total period. It is however clearly understood by the intending allottee(s) that the payment made by him/ them shall be first adjusted towards the interest, if any and the balance amount shall be adjusted towards the principal amount. In exceptional circumstances, the company may in its sole discretion condone the delay in making payments by the applicant charging an interest.
- 9. The applicant has specifically agreed that if due to any change in the layout, the said Residential plot/Villa/Shop ceases to be preferentially located, the company shall refund/adjust the amount of preferential location charges paid by the applicant in the last installment as shown in the payment plan. - 17 That the company shall endeavour to complete the development work/construction of the said Plot/Villa/shop within a period of 24 months of the allotment letter. However due to reason beyond the control of the developer/company like force majeure or calamity etc. no claim by way of damages/compensation or otherwise shall lie against the developer/company in case of delay in handing over the possession on account of any of the aforesaid reasons. - The maintenance, upkeep, repairs, security, landscaping and common services etc. of the projects shall be managed by the company or its nominated maintenance agency. The intending allottee(s) of the Plot/Villa/shop shall pay as and when demanded, interest free security deposit and maintenance charges for maintaining and up-keep of the project and various services therein as determined by the company or its nominated agency. Any delay in making payment will render the applicant liable to pay interest @18% p.a. Non payment of any of the charges within the time specified shall also dis-entitle the applicant from the enjoyment of the common areas and services. The intending allottee(s) agrees and consents to sign the maintenance agreement separately and will not question the same singly or jointly with other intending allottee(s).

- 28. If any misrepresentation/concealment/ suppression of material facts are found to be made by the applicant, the allotment will be cancelled and the earnest money as mentioned hereinabove shall be forfeited and the applicant shall be liable for such misrepresentation/concealment/suppression of material facts in all respect.

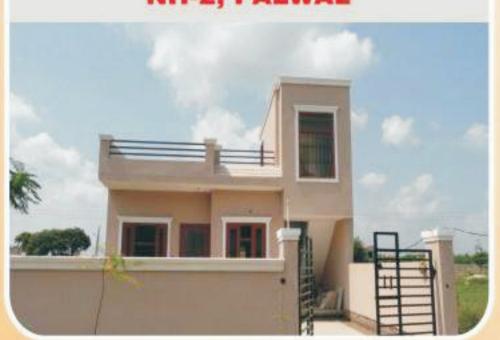

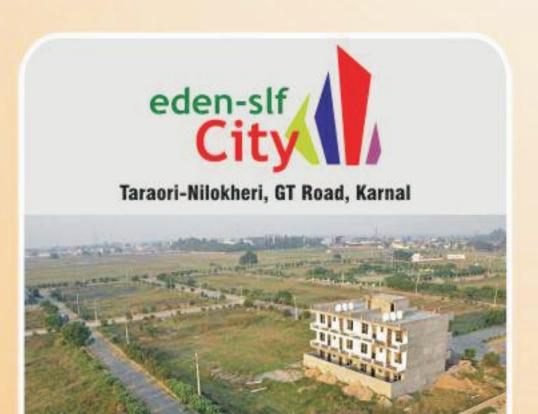

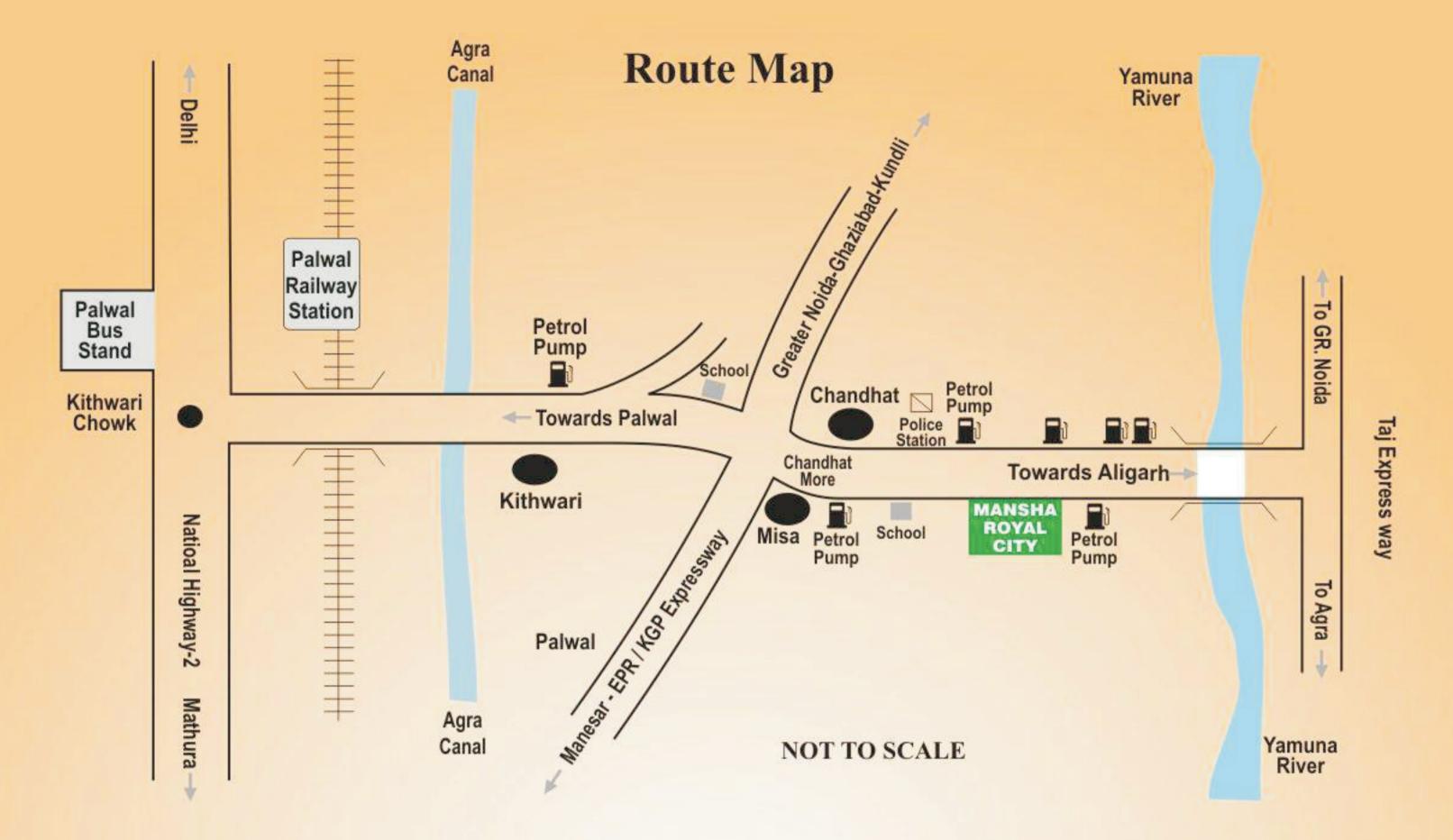
